**“ENACTING – Enable cooperation and mutual learning for a fair posting of workers” : a project with the financial support of the European Union (EaSI Programme)**

## The topic

ENACTING is about **transnational posting of workers** in EU: how to support the **practical cooperation and mutual learning among control authorities and social partners** engaged in the enforcement of Directive 96/71/EC, in the light of the new challenges settled by the Directive 2014/67/EU and by its transposition by Member States into national law.

## Aims and actions

ENACTING is aimed at enhancing transnational cooperation and knowledge of the existing practices for enforcement, among control authorities and among social partners. Namely the project acts for:

- **Enhancing administrative cooperation** (Labour Ministries, Labour Inspectorates, other Ministries in charge of relevant functions in controls) to support an effective mutual assistance at transnational level, proposing solutions to find the more effective procedures to facilitate cooperation. This specific line of action is pursued through the “*ENACTING Administrative Cooperation Working Group*” in charge of defining of specific “**Guidelines and practices for supporting mutual assistance**”

**in administrative cooperation for enforcement”.**

- **Fostering cooperation among social partners** (trade unions and employers' associations) to find more effective ways to inform and support workers and companies for a fair posting of workers. This line of action is pursued through the “*ENACTING Social Dialogue Working Group*” in charge of defining “**Guidelines for social dialogue for posting of workers**”.
- **Promoting knowledge and debate about the transposing national legislations:** two *Transnational Workshops* to follow up national legislations on the theme in Belgium, Germany, Italy, Romania (Florence, September 2015; Bucharest, March 2016).
- **Promoting the knowledge on the topic and the results generated by the project:**
  - *Final Conference: “ Building the European Pillar of Social Rights. The challenge of a fair posting of workers within EU. (Rome, 14 September 2016, Auditorium via Rieti).*
  - *Awareness National Seminars (Rome, Bucharest, Berlin, Brussels - September 2016)*
  - *Final restricted Workshop for stakeholders (Brussels, at EESC, 26 September 2016).*
